

## **Unfinished Business:**

- -Bylaws: no changes or amendments made at this time
  - -changes were made to the bylaws from December's meeting
- -7 outstanding referee's from last season: We still need to give out Referee gift cards for last season outstanding refs that we agreed on in December (Sam will email Brittany the last names and addresses for the seven we voted on)
- -Referee's from last season:
- -Brittany asked if 1099s were sent out to the refs who qualified . Sam said that they were sent to those who provided their SSN and will let Brittany know the exact amount

#### **New Business:**

- -New Positions and positions outlines:
  - -Karissa will help Brittany outline and edit position descriptions and roles
- -Having the people who held the positions last year to help with the positions might help
  - -Once finalized we can post online and add to bylaws

- -Referee Assignor: Opening Referee assignor position to all candidates for 2024 season. AYSC will be awarded overseeing this position and leading interviews
- -Auburn will manage the Referee assignor role. Auburn will hold interviews for that account and provide an outline for the job duties
- -We have a signed agreement with AYSC and FYSC (the clubs will work on this agreement to fine tune it)

#### -Working draft of MOU with Auburn and (hopefully Foresthill):

- -PHYSC will hold and manage the shared money
- -AYSC will manage the Referee Assignor
- -Auburn does not want to put money back into the referee account
- -Both AYSC and PHYSC owe the account about \$10,000 and there is about \$50,000 in the account (we will discuss more in the future if we want to put back into that account)
  - -Auburn is excited to work with us and want to work together during the season
- -Working together on the MOU so that all clubs have an understanding on items such as the shared money, referee assignor, meetings and discipline policy
  - -Meet and Greet will be Thursday, March 7th from 6-8pm at AYSC location

- -If they can't make it they can go to Mail in More in Auburn and its \$25 a coach (they will just need to invoice the club)
  - -Don't have to register on DOJ (Cal North does that)
- -2024 planning calendar:
  - -will work on this over the coming months
- -Potential 2024 registration rate increase:
  - -Last year Auburn's reg was (\$120, \$100, \$80) we were the same as Auburn
  - -Auburn also does early and late registration

- -Do we want every kid to get a medal or trophy (Auburn trophy might be able to do that and then teams can add to it if they want something customized)
  - -Possibly changings photo company so each kid gets a free group photo
    - -Lifetouch offers the minimum package for free
